

HAPPA TEMPORARY BOARDING AGREEMENT

THIS AGREEMENT dated ___/___/___ made by and between Horses and Ponies Protection Association hereinafter referred to as HAPPA, located at Shores Hey Farm and (Owner's name) _____ residing at (Owner's address) _____ and contactable by (Owner's telephone number) _____ hereinafter referred to as "OWNER." These parties warrant that they have the right to enter into this AGREEMENT.

1. FEES, TERMS AND LOCATION

In consideration of £60 per equine per night accommodation provided paid by OWNER on collection of the equine, HAPPA agrees to board the herein described equine (s) until at such time between 9am-10am the subsequent day, that equine can be collected and suitably loaded to leave Shores Hey Farm.

3. FEED AND FACILITIES

HAPPA agrees to provide the following

A CLEAN STABLE WITH X 1 BALE OF SHAVINGS BEDDING

HAY ON FLOOR

FRESH DRINKING WATER VIA AUTOMATIC DRINKER

A NIGHT CHECK OF THE EQUINE TO ENSURE THEY ARE COMFORTABLE

A THOROUGH CLEANSE OF THE STABLE FOLLOWING USAGE AND DISINFECTANTING.

4. TERMS OF STAY

The Equine must be collected from HAPPA, Shores Hey Farm by 10am the subsequent day.

Please note that during the terms of stay the movement of the equine to and from stables/ trailer is to be conducted by the OWNER or qualified personnel acting on behalf of the owner e.g., Veterinary Surgeon.

HAPPA request that unless expressly permitted by HAPPA Senior Equine Team that attendance to the equine is within the 9am-10am window in order to protect visitors to Shores Hey Farm. Outside of these hours may be considered as trespassing, unless expressly permitted by HAPPA Senior Equine Team.

Provisions will be made to ensure where possible the equine will not be disturbed or touched by members of the public.

5. RISK OF LOSS

During the time that the equine/ s is/are in the custody of HAPPA, HAPPA shall not be liable for any sickness, disease, theft, death or injury which may be suffered by the equine/ s. This includes, but is not limited to, any personal injury or disability the horse may receive while of HAPPA's premises. OWNER fully understands and hereby acknowledges that HAPPA does not carry any insurance on any equine/s not owned by HAPPA, including, but not limited to, such insurance for boarding or any other purposes, for which the equine/s is/are covered under any public liability, accidental injury, theft or equine mortality insurance, and that all risks relating to boarding of horse (s), or for any other reason, for which the horse (s) is/are in the possession of HAPPA, *are to be borne by OWNER*.

6. HOLD HARMLESS

OWNER agrees to hold HAPPA harmless from any claim resulting from damage or injury caused by said equine, OWNER or his guests and invitees, to anyone, including but not limited to legal fees and/or expenses incurred by HAPPA in defence of such claims.

7. EMERGENCY CARE

HAPPA agrees to attempt to contact OWNER, at the following emergency telephone number/s (_____), should HAPPA feel that medical treatment is needed for said equine/s, provided however, that in the event the HAPPA is unable to so contact OWNER within a reasonable time, which time shall be judged and determined solely by HAPPA, HAPPA is then hereby authorised to secure emergency veterinary care and/or farriery care, and by any licensed providers of such care who are selected by HAPPA, as HAPPA determines is required for the health and well-being of said equine/ s. The cost of such care secured shall be due and payable by OWNER within fifteen days from the date OWNER receives notice thereof, provided however, that HAPPA is authorised to arrange direct billing by said care provider to the OWNER.
